Geriatric Assessment, Management & Solutions, LLC will charge the client(s) \$115.00 an hour for services provided by an Aging Life Care Specialist. The *Principal Fiduciary/Aging Life Care Specialist* rate is \$140.00/hour. These rates are subject to change on an annual basis, not to exceed 5% (five percent). An initial retainer of \$500.00 is required, which retainer shall be applied to the first billing invoice. A minimum 1 hour visit each month is required. Travel time will be billed at the hourly rate (see Fees and Services sheet); however, GAMS does not bill for mileage, and will strive to mitigate the amount of travel time involved in each instance. The client(s) will be invoiced on a monthly basis. The client(s) agree to pay the invoice within fifteen (15) days of receipt of the invoice. A 10% Late Payment Charge will be applied if payment is not received within 15 days. The client(s) also agree to reimburse Geriatric Assessment, Management & Solutions for all costs and expenses incurred by GAMS on behalf of the client(s) and/or service recipient(s).

The client(s) and/or their authorized representative(s) or heirs also agree to pay all legal, court and any costs incurred by Geriatric Assessment, Management & Solutions in the collection of any unpaid costs or fees. This contract contains the entire agreement between the parties and there are no other promises or conditions in any other agreement whether oral or written.
